TERMS, CONDITIONS, AND LIMITATIONS FOR THE STORMFORCE OF JACKSONVILLE, LLC REFERRAL PROGRAM

StormForce of Jacksonville, LLC (the "Company") shall issue a referral fee of \$50.00 to any individual (the "Referrer") who refers a property owner to the Company if that referral results in a completed roof inspection by the Company.

The Company shall issue a referral fee of \$250.00 to any Referrer who refers a property owner to the Company if that referral results in a completed new roof installation performed by the Company.

This Referral Program (the "Program") is subject to the following terms, conditions, and limitations:

- 1. A Referrer under this Program is eligible to receive a referral fee of \$50.00 for a completed roof inspection and a subsequent referral fee of \$250.00 for a completed new roof installation. Referrers can earn a maximum of \$300.00 (inspection fee + roof installation fee) for each referral if the referral results in both a completed roof inspection and completed new roof installation performed by the Company.
- 2. For the purposes of this Program, a "completed roof inspection" shall occur when a referred property owner meets with a Company representative and permits that representative to perform a comprehensive roof inspection for the purposes of inspecting the existing roofing system and related components.
- 3. For the purposes of this Program, a "completed new roof installation" shall occur when a referred property owner 1] meets with a Company representative and permits that representative to perform a comprehensive roof inspection for the purposes of inspecting the existing roofing system and related components, and 2] the referred property owner retains the Company to remove the existing roofing system and 3] the referred property owner contracts-with the Company to install a new roofing system.
  - a. The Company shall *not* issue a \$250.00 referral fee for referral resulting only in a roof repair. Only a completed new roof installation entitles the Referrer to a \$250.00 referral fee. For the purposes of this Program, a roof "repair" shall mean any roofing services which remove and replace less than 100% of the existing roof covering.
  - b. The Company shall *not* issue a \$250.00 referral fee unless the referred property owner contracts-with, retains, and hires the Company to perform the new roof installation.
- 4. The referral fees referenced in this Program shall be payable by Company check in U.S. dollars. The Company shall issue the appropriate referral fee within seven (7) to ten (10) days after a completed roof inspection or completed new roof installation.
- 5. Referrers shall be eligible to receive a referral fee pursuant to this Program only if the referred customer is a property owner with full rights, title, and authority to retain the Company for roofing services.
- 6. Referrers shall be eligible to receive a referral fee pursuant to this Program only if the referred property owner and roofing system subject to inspection and possible replacement are located within Nassau County, Clay County, Duval County, Flagler County, and St. John's County, Florida.
- 7. This Program specifically excludes, and shall not apply to, any referrals for roofing services which are to be paid for by property insurance proceeds. This Program is limited to retail roofing installations. For the purposes of this Program, a "retail" roofing installation is a roofing project wherein the property owner pays for roofing, construction, and related services with funds that are independent of any insurance proceeds or property damage claims.
